## 1. CDC Cancer Conference: Report from CCRAB Chair

This Fall, Dr. Cogle represented CCRAB at the CDC Cancer Conference in Atlanta, GA. He met with state cancer consortium leaders from around the nation. Examples of highly effective cancer patient advocacy programs were presented and discussed. Dr. Cogle is incorporating knowledge gained from the conference into our CCRAB operations.

## 2. Telehealth Advisory Council Report: Expanding Florida's Use and Accessibility of Telehealth

In October, the Telehealth Advisory Council released a report of recommendations for the expansion of telehealth services in our state. The report identifies six topic areas where current opportunities exist to support the expansion of telehealth in Florida: defining telehealth, health insurance coverage, reimbursement for telehealth, health care practitioner licensure, patient/consumer protections, and technology. The Florida Cancer Plan 2015-2020 includes a goal to facilitate Florida-based telemedicine for high-quality cancer patient cancer, genomics, and advanced cancer research analytics. Whereas, cancer is not specially mentioned in the 27-page report, the entire report is applicable and supportive of cancer patients' and oncology professionals' shared use of telehealth.
